### TERMS & CONDITIONS TO BIDDERS:-

1. The vehicle will be sold on “as is where is” condition and the Bank shall not be responsible for any defects latent or otherwise, damage, decay or any missing parts of the vehicles.
2. **Vehicle is available for inspection on 28.11.2023 & 29.11.2023 between 10.00 AM to 02.00 PM at Himachal Pradesh Gramin Bank Head Office, Jail Road Mandi(HP).**
3. **The offers shall be dropped in the tender drop box or sent by post and should reach Himachal Pradesh Gramin Bank Head Office on or before 30.11.2023 by 04:00 PM. The tender must enclose KYC documents (Aadhaar Card, PAN Card, Driving License, Passport etc.)**
4. **The bids will be opened on 01.12.2023, 12.30 PM at Head Office.**
5. Bidder may present/depute representative duly authenticated under your letter, to our office in whose presence bids will be opened. However, bids would be opened even in the absence of any or all of the bidder’s representatives.

6. This tender is neither an agreement nor an offer and is only an invitation by the Bank to interested parties who are qualified for submission of documents. No contractual obligation whatsoever shall arise from the tender process until a formal supply order is sent to Successful bidder.
7. The purpose of this tender is to provide the bidders with information to assist the formulation of their proposals. This tender does not claim to contain all the information each bidder may require. Each bidder should conduct its own investigations and analysis and should inspect the vehicle before submitting the proposal.
8. **Separate Demand Draft of EMD for Rs. 25000/- must accompany with the proposal for each vehicle and DD should be in favour of 'HIMACHAL PRADESH GRAMIN BANK'.**
9. **Intending buyer should submit their offers in sealed covers, duly mentioning on the cover "OFFER FOR PURCHASING VEHICLE NUMBER \_\_\_\_\_" along with EMD amount of Rs. 25,000/- (Rupees Twenty Five Thousand Only). Please mark your Contact No on the envelope of the bid.**
10. Demand draft should be attached inside the sealed cover containing the offer letter. Kindly note that **EMD in any other form will not be accepted and without EMD tender will be rejected.**
11. **The EMD amount shall be refunded to the unsuccessful bidders after completion of sale process & NO interest shall be payable on the Amount.**
12. **Unsealed/tempered bids or bids received after stipulated date and time, if any will be summarily rejected. GST as applicable will be borne by the successful bidder, which is extra and over and above the bid amount.**
13. The Bank reserves the rights to accept or reject any or all offers in part or full or put off or postponed the sale without assigning any reason whatsoever. Acceptance/rejection of bids shall be at the sole discretion of the bank and cannot be claimed as a matter of right by the bidder for acceptance of the bid.
14. **The acceptance of the offer will be intimated to the successful bidder and shall be deemed as personal notice of intimation to successful bidder and shall be binding on him. The Bank shall require a minimum of 7 day time for intimating the acceptance of the offer.**
15. **The successful bidder has to make the payment of total amount within 03 working days after intimation by bank in this regard to the successful bidder.**
16. Refund of Earnest Money deposit will be refunded only after furnishing proof of RC duly transferred in favour of the successful bidder within a period of 1 month.
17. In case successful tenderers desired to re-register the vehicles outside Himachal Pradesh, where the vehicles needs to be produced physically, an extra amount of Rs. 50,000.00 has to be deposited other than EMD which will be refundable only after furnishing proof of RC duly transferred in favour of the bidder within a period of 1 month. Once the release order issued, this office will not be responsible either for safe custody or for any loss or damage to the subject vehicles.
18. **In case of failure/default and / or refusal by the successful bidder, whose offer has been accepted, to pay the balance amount within 03 working days after intimation by bank in this regard to the successful bidder, the EMD amount paid shall be forfeited.**
19. **The Bank shall have the option and liberty to offer the vehicle to the next highest bidder (after negotiation at Bank Discretion), if the successful bidder fails to make payment or take delivery of the vehicle within the stipulated period.**
20. However, the purchaser shall have no right or claim whatsoever against the Bank, after the stipulated period mentioned in the notice is over and bank is not bound to handover the vehicle or be answerable in any manner for any loss that they may incur in this regard.
21. The successful bidder shall have to execute the Delivery Note for having received the vehicle.

22. Vehicle along with all documents will be handed over to the successful bidder, only after receipt of full and final payment for the vehicle, failing which EMD will be forfeited. Vehicle will be delivered from Head Office, Mandi.
23. Obtention of "No Objection/Clearance Certificate and transfer of ownership" from the concerned RTO will be the responsibility of the purchaser only. The successful bidder shall arrange to get the vehicle transferred/registered within 30 days from date of sale and shall submit a copy of Registration Certificate within a week thereafter.
24. The No Objection/Clearance Certificate should be submitted by the successful bidder/purchaser before taking delivery of the vehicle and it should be in the name of successful bidder only. However, all the required RTO forms furnished by the purchaser will be signed and stamped at our end with date of sale effecting transfer of the vehicle sold. Transfer of ownership charges and other charges shall be borne by the successful bidders only.
25. In case of any dispute, decision of Chairman will be final and binding on all bidders.
